Council Tax approved to increase by 4.9%

Full Council has approved the 2019/20 budget today (15 February 2019), which includes the setting of Herefordshire Council tax rates which will come into effect from April 2019.

The Medium Term Financial Strategy for 2019/20 to 2021/22 was also approved today which outlines the measures Herefordshire Council has taken since 2010 to deliver savings, and provides a financial forecast up to 2021/22. Central government's Revenue Support Grant has reduced from £60.1m in 2010/11 to £0.6m in 2019/20, forcing Herefordshire Council to deliver £90m of savings since 2010. Despite these financial challenges, the council continues to deliver a balanced budget and has increased general and earmarked reserves.

Around 70% of Herefordshire Council's main income stream comes from Council Tax. To achieve a budget contribution of just over £104m for 2019/20, a 4.9% Council Tax increase has been approved. The increase will be made from a core Council Tax increase of 2.9% and a 2% increase to the precept ring-fenced for the delivery of adult social care.

An average band D property will now pay Council Tax at £126.23 per month (over 12 months). This tax rate excludes the individual precepts set by each parish council, West Mercia Police and Hereford & Worcester Fire and Rescue Service which will be decided in March 2019.

Some residents may be eligible for a Council Tax Reduction, or even pay nothing in certain circumstances (such as young adults who have left care) – see note and link at end of report. Those who are still experiencing financial difficulty may be entitled to a hardship payment.

Lugwardine man fined for attempting to fell a protected tree

Herefordshire Council has won a prosecution case against a man found guilty of undertaking unauthorised works to a tree protected by a Tree Preservation Order (TPO).

On 4 February 2019, in a case taken to Hereford Magistrates Court by Herefordshire Council's Conservation team, Roy Albert John Harrison (78) of Three Penny Bit Cottage, Lugwardine, pleaded not guilty to consenting to unauthorised works to a tree protected by a Tree Preservation Order. The court found Mr Harrison guilty and ordered him to pay costs of £5,000, a fine of £180 and a victim surcharge of £30.

Attempted tipping of commercial waste at Recycling Centre

Herefordshire Council has won an enforcement case against a man found guilty of unlawfully disposing of waste at a Household Recycling Centre.

The case was taken to Hereford Magistrates' Court by Herefordshire Council's Community Protection Team on Wednesday 16 January 2019. Samuel Jones Bowstead, 27, of The Leys Cradley, pleaded guilty to failing in his duty of care to transfer waste to an authorised person and to failing to secure the transfer with a written description of the waste. Mr Bowstead received a fine of £270, a victim surcharge of £30 and was ordered to pay costs of £1500.

During a public consultation in February and March 2018 on the Hereford Transport Package, which includes the Hereford bypass, 87% of people who responded said they approved of the walking, cycling, bus and public space improvements proposed. Since then, work has been taking place to develop these further.
